 - 4. The officers who are now under transfer orders are entitled to draw transfer grant/disturbance allowance, transfer T.A. and other consequential benefits.

- 5. All the Officers who are under orders of transfer are hereby directed to inform the High Court about the date of relief in the previous post and the date of joining in the new post within seven days from the date of joining in the new post.
