In partial modification of earlier Orders of transfers and postings of Junior Civil Judges made in the High Court's Proceedings read above, the High Court is pleased to pass the following order:-

In case, the above officers from whom they have to take charge or to whom they have to handover charge, are either on leave or not available for any other reason, the concerned Prl. District and Sessions Judges/Unit Heads, shall make alternative arrangements under intimation to the High Court. Further the officers mentioned in Column No.4 who are holding full additional charge of the posts mentioned in Column No.2 are directed to hold the Court Proceedings atleast once in a week if the said court is located away from the place they are working as per the convenience of the Bar Association and litigant public in view of the circular instruction issued by the High Court and inform the same to the High Court for information.

- NOTE:**
1. The officers from Sl.Nos.1 to 4 & 6 shall get themselves relieved from their present posts and join in their new posts on or before **06.05.2023** without fail.
 2. The officer at Sl.No.5 shall get herself relieved from the present post i.e., after expiry of her Maternity Leave by 11.05.2023 and join in her new post on 15.05.2023.
 3. All the Officers under orders of transfer are directed to pronounce their judgments/orders which were already reserved and join at their new stations.
 4. The officers who are now under transfer orders are entitled to draw transfer grant/disturbance allowance, transfer T.A. and other consequential benefits.

5. All the Officers who are under orders of transfer are hereby directed to inform the High Court about the date of relief in the previous post and the date of joining in the new post within seven days from the date of joining in the new post.
