All the newly appointed 39 Junior Civil Judges are hereby directed to take charge of their respective posts on 04.10.2023 without fail.

In case, the above officers from whom they have to take charge/ handover charge, are either on leave or not available for any other reason, the concerned Principal District and Sessions Judges / Unit Heads, shall make alternative arrangements under intimation to the High Court.

The above 39 Junior Civil Judges are further directed to get themselves relieved from their respective posts on **06.10.2023** by handing over the charge to the officers from whom they have taken charge and proceed to Telangana State Judicial Academy, Secunderabad and report before the Director, Telangana State Judicial Academy, Secunderabad, for undergoing Basic Training Programme from **07.10.2023** onwards. During the training period all the above Junior Civil Judges are under the control of Director, Telangana State Judicial Academy, Secunderabad for all purposes.

The officers who have taken charge from the newly appointed Junior Civil Judges will be full additional charge of the said posts during the training period of those officers or until further orders.

The above 39 Junior Civil Judges are further directed to submit Medical Fitness Certificate obtained from a Doctor not below the rank of Civil Surgeon/District Medical & Health Officer, to the respective Unit Heads. The properties and relations statements, in the prescribed format (enclosed) have to be submitted to the Director, Telangana Judicial Academy, Secunderabad, while reporting to training. In turn the Director, Telangana, Telangana State Judicial Academy, Secunderabad shall forward the copy of the same to the respective Principal District & Sessions Judges and original to the High Court for the State of Telangana, Hyderabad.

The Junior Civil Judges, mentioned in Column Number 2 are transferred and posted to the stations mentioned in Column Number 3 of the corresponding row. Further, the officers mentioned in Column Number 2 are directed to handover charge of their post and also the posts which they have been holding full additional charge, to the officers mentioned in Column Number 4 of the corresponding row, as directed hereunder, and get themselves relieved and proceed to their new stations and take charge of their respective post and also the posts which his/her predecessor is holding full additional charge, from the officers mentioned in Column Number 5.
