The officers mentioned in Column Number 4, will be full additional charge of the post(s) mentioned in Column Number 2, till the substitute posted takes charges or until further orders which ever is earlier.

Further the officers who are holding full additional charge of the post(s) if any are directed to hold the court proceedings at least once in week if the said court is located away from the place they are working as per the convenience of the Bar Association and litigant public in view of the circular instructions issued by the High Court and inform the same to the High Court for information.

- NOTE: 1. The officer at Sl.No.1 shall get herself relieved from her present post and join in her new station by 24.11.2023 and all the other officers shall themselves relieved from their present posts and take their respective posts with immediate effect.
2. All the Officers now under orders of transfer and posting are directed to pronounce the judgments/orders which were already reserved and join at their new stations.
3. All the Officers who are under orders of transfer are hereby directed to inform the High Court about the date of relief in the previous post and the date of joining in the new post within seven days from the date of joining in the new post.
